

Prof. Dr. Wolfgang Wessels

Prof. Dr. Wolfgang Wessels is holder of a Jean Monnet Chair ad personam for Political Science, professor emeritus at University of Cologne, and Director of the Centre for Turkey and European Union Studies (CETEUS) at the University of Cologne.

He has a master's degree in Economic and Political Science (1973), a doctorate in political science from the University of Cologne (1979) and he received the Venia legendi in Political Science of the University of Bonn in 1990. Since summer 1994, he is chairholder and since 2011, has an ad personam Jean Monnet Chair for Political Science at the University of Cologne. In 2016 he retired but continued to work on his research priorities based on a mandate from the rector. From 1981 to 1994 he was head of the political department of the College of Europe and since then he is a visiting professor both at the Bruges and Natolin campus. Furthermore, he teaches at the Diplomatic Academy Vienne and at the European Online Academy. Since 2010 he is Vice-President of the German consortium for the foundation of the Turkish-German University, Istanbul and since 2019 he is a part-time professor at the European University Institute in Florence. Wessels also taught at Sciences Po, Paris, as holder of the Alfred Grosser chair.

In 2011 he was awarded for his 'Lifetime Achievement in Contemporary European Studies' for studying the European Council by the University Association for Contemporary European Studies (UACES). In 2015 he was awarded with the "Universitätspreis Forschung" by the University of Cologne for his excellence in research and in 2016 with the "Vision for Europe" award by the Prague European Summit.

Prof. Wessels is co-editor of the "Jahrbuch der Europäischen Union" (40th Edition) and the "Europa von A-Z. Taschenbuch der europäischen Integration" (15th Edition) and has published widely in leading English and German journals and edited volumes. He has coordinated several research and teaching networks as well as EU funded projects like TRACK, VIADUCT and FEUTURE. He was the chairperson of the Executive Board of the Institut für Europäische Politik (IEP, Berlin) from 1995 to 2018 and chairperson of the Executive Board of the Trans European Policy Studies Association (TEPSA, Brussels) from 1995 to 2016. His areas of research and teaching include the political system of the European Union, especially the institutional architecture with the European Council and the role of national parliaments as priorities, selected cases of the EU's external action- especially the relations with Turkey, narratives of the EU's deepening and widening, specific modes of EU's governance as well as assessments of theories of and strategies for European integration.
